4. Use trash talk; profane, obscene, or vulgar language, under any circumstances, on or off the contest area.
5. Engage in objectionable demonstration of dissent or unsportsmanlike conduct such as throwing equipment or any other forceful action.
6. Except the coach/manager, contend the decision of an official.
7. Refuse to abide by an officials decision.
8. Appear in the contest area under the influence of alcohol or drugs.
9. Consume Alcoholic beverages while the team is participating in a game or in the contest area.

**PENALTY FOR BEING INVOLVED IN ANY OF THE ABOVE WILL RESULT IN:**

Minimum Penalty: Warning by the official or site supervisor.

Medium Penalty: Suspension from the current game and any subsequent games on the same day.

Official may call the game and award a forfeit victory to the opponent.

WVGS board may suspend the individual/team from between one additional game and from the league play at their decision.

Maximum Penalty: Penalty will be determined by the WVGS board of directors.
